### **IESF Branding update**

At the Regional meeting in Istanbul last month we presented the results of the global research on our IESF branding. We asked all IESF partners 3 questions:

- 1. IESF stands for International Executive Search Federation. Do you want to change the word Federation in our name?
- 2. Do you thinkthe IESF logo deservesan update or rebranding?
- 3. A possible branding change for IESF also has consequences for your local communication tools. Are you able and willing to make the requested changes locally if the digital tools are shared with you?

IESF partners concluded that the IESF brand has the advantage of existing 20 years and means something in the market. The majority is in favor of keeping the IESF letters, but in the future we can transform the "F" of Federation into another name that represents us better. Most of you feel rather comfortable with the IESF brand: it has a positive meaning and reflects quite well an union between autonomous partners. There is a great demand for updating & refreshing our IESF logo, as it seems outdated and not showing our Executive Search standards.

We will kick-off with an IESF project team that will lead the rebranding project. Claudia Montedonico will lead this team on behalf of the LC because of her communications background. Normand will also be part of this team based on this branding experience.
